Brief Statement of Accident: At 1918 hours units responded to an accident @ I-75 N/B I-475 W/B ramp, the vehicle was located unoccupied on the west side of the roadway. An accident report was made and the vehicle was towed to the Toledo Police Tow Lot. At 0232 Family members of the deceased initiated a missing person report. During the missing person investigation it was determined the deceased's cell phone was in the vehicle which was located at the Toledo Police Tow Lot. Units responded to the accident scene and located the deceased behind a concrete barrier wall on the east side of the roadway. Unit 1 was traveling N/B on I 75 and proceeded onto the I-475 W/B ramp. Unit 1 lost control of his vehicle and struck the east guardrail. the vehicle traveled across the roadway then struck the west concrete barrier wall where it came to rest. Unit 1 was ejected from the vehicle during the initial impact.
